S.O.P.

1- The Institution Academic/Curriculum Committee shall meet at least once in a month to identify areas of improvement.

- 2- The coordinator of the committee will schedule a meeting in consultation with the honorable Chairman of the committee and accordingly inform all other members well in advance.
- 3- The coordinator of the committee will be responsible to maintain all the records, documents such as directions, Circulars, notifications and GR of different authorities related to functions of respective committee and minutes of the meetings and will summit data as and when required.

Functions of Academic Committee

- 1. The Academic Committee plays a crucial role in overseeing and ensuring the academic standards and quality of education by Planning, execution and monitor teaching schedules.
- 2. Institutional Curriculum/Academic Committee monitoring and supervising implementation of Curriculum prescribed by Regulator for each professional year.
 - a. The teaching schedules shall be of integrative in nature and shall be announced one month before.
 - b. The teaching schedules shall be hosted on institutional website as well as Learning Management System portal
 - c. Academic/Curriculum Committee ensured allocation of teaching hours/weeks to all subjects in each professional year in alignment with provisions of NCISM.
 - d. Institution Academic Committee aligned the organizational Theory, Practical & Clinical Training with the Competence Based Curriculum prescribed by NCISM
 - e. Following documents got developed and maintained by Institutional Academic/Curriculum Committee
 - a. Teaching Plans for theory & practical
 - b. Master Time Table for Theory, Practical and Clinical postings
 - c. Clinical Rotation Plan / schedule
 - d. Annual Calendar for Field Visits
