

As per resolution of the minutes of the meeting chaired by the Director, Vaidya Yagya Dutt Sharma Ayurved Mahavidyalaya, Khurja dated 25.11.24 with the agenda to formation of different committees for the progressive development of the academics and other activities of the college, 'SOP' for functioning of Anti-Ragging Committee is as follows-

S.O.P.

- 1- The Anti-Ragging Committee along with Anti-Ragging SQUAD shall meet at least once in every quarter to identify areas of improvement.
- 2- The coordinator of the committee will schedule a meeting in consultation with the honorable Chairman of the committee and accordingly inform all other members of Anti-Ragging Committee along with Anti-Ragging SQUAD well in advance.
- 3- The coordinator of the committee will be responsible to maintain all the records, documents such as directions, Circulars, notifications and GR of different authorities related to functions of respective committee and minutes of the meetings and will summit data as and when required.

FUNCTIONS:

- 1. The Anti Ragging Committee with Anti-Ragging SQUAD plays a crucial role in ensuring the safety and well-being of students in educational institutions.
- 2. It is responsible for monitoring and preventing any form of bullying or harassment among students.
- 3. The committee investigates complaints, conducts awareness programs, and takes necessary actions to create a safe and positive learning environment.
- 4. By enforcing strict rules and regulations, the committee aims to promote a culture of respect and tolerance within the campus.

- 5. Overall, the scope and function of the Anti Ragging Committee are essential in upholding the dignity and rights of every student.
- 6. The committee shall check following measures for prevention of Ragging
 - 1- Disseminate necessary information related to zero tolerance policy & prohibition of ragging through digital media, prospectus of admission etc.
 - 2- Shared and displayed contact numbers of officers/Faculties & staff accountable for antiragging measures in campus at prominent places especially any potential ragging Hot-spots
 - 3- Submission of Duly signed undertaking of Students before admission in College & Hostel.
 - 4- Organized Sensitization Programs for Seniors & Fresher students
 - 5- Organized induction & Orientation programs for Fresher students vis-à-vis Anti-ragging
 - 6- Organized Cultural, Sports & extra-curricular activities as platform for promoting interaction among seniors and freshers in the presence of faculties
 - 7- Constituted "Mentoring Cell"
 - 8- Organized Counselling session through Professional Counsellors for freshers and other
 - 9- Reporting & redressal of Ragging Cases It shall be the duty of the committee to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the Institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the authority observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incidents of ragging, and considerations such other relevant information as may be required.
