- Quantity per pack: 10 ml
- Each 10 ml of Swarnaprashan contains:
- Swarna Bhasma: 77 mg
- Ghrita (clarified butter): 1 part
- Madhu (Honey): 4 parts
- Excipients and Preservatives
- Dose for each age group:

Age Group	Dose (drops/day)
6 months – 1 year	2 drops
1 year – 2 years	4 drops
2 years – 3 years	6 drops
3 years – 4 years	8 drops
4 years – 5 years	10 drops
